Save Money as a Member

Member Packages: SimpleSavers offers 3 Packages for all Members to begin saving money every month:

1. **Basic Savings and Discount Program** - Customer pays a subscription fee of \$40/month and receives the **Basic Benefits Package**. (An annual \$35 Registration Fee applies.)
2. **Save50® Savings and Discount Program** - Member pays a subscription fee of \$65/month and receives the **Basic Benefits Package** and a **\$50 US Savings Bond every month**. (An annual \$35 Registration Fee applies.)
3. **Save100® Savings and Discount Program** - Member pays a subscription fee of \$90/month. Gets the **Basic Benefits Package** and a **\$100 US Savings Bond every month**. (An annual \$35 Registration Fee applies.)

Member Referral Program: Subscription Reduction Plan – SimpleSavers will pay any Member to share our program with others. If any Member refers another person to Simple Savers and they join, Simple Savers will pay that referring Member \$5 per month, every month their referral remains a Member of Simple Savers.

Member Representative Opportunity - In addition to becoming a Member, you can become a Representative by purchasing a Business Starter Kit and then enrolling in the monthly **MemberRep® Tools Package** for an additional \$15/month. Personal Production Income

1. **Personal Residual Commissions (level one)** – earn 12.5% - or \$5 - *every month* on the \$40 commissionable portion of any Basic Benefits Package you sell to either a Member or a MemberRep.

Team Development Income

3. **Sales Organization Residual Commissions** – Whenever you make 3 personal sales, you qualify to earn 12.5% - or \$5 - *every month* on the \$40 commissionable portion of any Basic Benefits Package sold in your entire organization through 5 levels of Members and MemberReps.

4. **6th Level Bonus** – Automatically qualify to earn 7.5% - or \$3 - *every month* on the \$40 commissionable portion of any Basic Benefits Package sold on your sixth level by either becoming a “Producer” (selling 3 Memberships in your first 45 days) OR, after 45 days, have a total of 10 frontline sales.

Leadership Income

5. **Team Leader (TL) Bonus** - A Team Leader is an MR who has 3 separate legs each with an MR. As a TL, you can earn a one-time bonus on MR enrollment training on your 4th personally sponsored MR and on MRs sponsored in your organization through 2 additional generations of MRs. [Compensation illustrated below:]

6. **Executive Director (ED) Bonus** - An Executive Director is an MR who has developed 3 separate legs each with a Team Leader and has a minimum of 100 total group memberships in his/her total organization. As an Executive Director you'll earn an additional one-time bonus on new MR enrollment training in your entire organization down to the first Executive Director in a leg. [Compensation illustrated below:]

7. **Senior Executive Director (SED) Infinity Bonus:** A Senior Executive Director is an Executive Director with at least one Executive Director in his/her organization and a total of 100 group memberships outside of his/her largest ED leg.

As a Senior Executive Director you'll earn a bonus of 2.5% - or \$1 - **every month** on the \$40 commissionable portion of any Basic Benefits Package sold in your entire organization below your 6th level until you reach another Sr. Executive Director. If the first downline Sr. Executive Director is sponsored within your first 6 levels you are paid 2.5% or \$1 on every enrollment down to the 7th level of your first downline Sr. Executive Director.

SimpleSavers pays out a potential of 72% of the commissionable portion of its product revenue to MemberReps - one of the highest in the Industry! And, SimpleSavers has created a program so simple and so complete that, if someone is dedicated, they have the potential to attain total financial freedom in just a few short years.
